Neighborhood Guest Pass Guidelines

- Pass Holders must wear the current wrist band at all times while on grounds. Wrist bands can be obtained at the office.
- Pass holders age 18 and older may be on the grounds from dawn until dusk and do not need to sign in.
- **Family members who are under 18 may not be on the grounds unaccompanied when the office is closed.** Office hours are posted on the office door, and there is a sign at the Racefield gate that indicates when the office is closed.
- **Children age 12 and up** may be unaccompanied during office hours only, and only with parent's permission. Please make sure your children know they need to sign in at the office and depart when the office closes.
- When the office closes, all those under 18 must depart or be accompanied by a parent or an Annual Pass holder who is 18 or older.
- Please wear appropriate attire. Clothing should not be revealing, distracting or demeaning.
- Recreation equipment is available to borrow at the office at no charge. Be sure to return it when you are done.
- Overnight guests pay a fee and get priority to use our recreation facilities. Please yield to our overnight guests at the recreation areas such as the basketball, softball, and volleyball courts.
- If you drive on the property, please observe the posted speed limits.
- When riding bicycles on trails, use caution and yield to those who are walking. If a trail is marked NO BIKES, please keep off. Helmets must be worn.
- Dogs are allowed, but only if they are on a leash and well-behaved (no constant barking). Please clean up after your dog by scooping it into the woods or using the doggy depot near the Racefield Gate. Thanks!
- Skateboards are allowed only on the basketball court and at Edgewood Pavilion (large pavilion by the tennis courts). Do not ride on the tennis courts and do not ride on any tables or stage platforms at Edgewood. Non-compliance can cause you to lose your Annual Pass. Helmets are required.
- Alcohol is not permitted on the grounds.
