# Significant Accomplishments 2021

- **27 Teams raised \$20,000 in our 27th Annual Golf Classic.**
- Generous donors provided the funds for a new Zero Turn Lawnmower.

## **Twelve young people made first time commitments to Jesus at camp this summer!**

- 68 pastors came to WCRC for personal and family retreats at no charge and discounted rates.
- **Once again overnight, camp had more campers—296—than in 2019.**
- Our Summer Celebration raised over \$10,000 for camp scholarships.
- **While COVID prevented Family Fun Day in April, we had the FAMILY HARVEST FEST in October instead, with 532 participants!**
- Once again, our giving partners gave a record amount. Our Year-end appeal raised \$82,471. WCRC ended the year in the black!
- **John Bowman, Charlie Brenneman, Jasmine Harris, Larry McLaughlin, Ray Nice, and Valerie Wermuth joined the board.**
- We were able to hold Christmas Around the Campfire for the first time in two years and had 72 participants!
- **Former Head Counselor Zach Dey became the Associate Pastor of Williamsburg Mennonite Church.**
- Our Campground had a record-setting year for occupancy and income.





- 2010** • Cabin Village is completed and exceeds income projections
- 2010 to 2012** • Endowment Fund Policies re-written resulting in over \$80,000 in donations given since then.
- 2012 to 2014** • Financial review results in positive Net Income for the last 6 years
- 2015 to 2020**
  - Facility Renewal Program to update all the lodging buildings at WCRC
  - Master Plan reviewed to map out the future building projects
  - Mission Vision and Values reviewed and updated
- 2019 to 2020** • Donor focus replaces member focus to streamline donor development.

2. Provide more meeting space and dining space to better serve our guests.
